The foodstuffs corresponding with the food simulants are stipulated in EU regulation 10/2011 EC up to the latest amendments. Regulation (EU) 2020/1245 amending and rectify correction Regulation (EU) No. 10/2011.

The material and/or object referenced above, under normal and foreseeable conditions for use does not cause any unacceptable alteration in the composition, or any alteration in the organoleptic characteristics of the food product and is fit for use in contact with: All types of food products.

## Migration test of substances in a simulant:

For overall migration and specific migration (if necessary), the packaging is subjected to a migration test in the following simulants (directive 2007/19/CE):

Simulants	During	Temperature
A: 10% Ethanol	10 days	40°C
B: 3% Acetic acid	10 days	40°C
D1: 50% Ethanol	10 days	40°C
D2: Rectified olive oil	10 days	40°C

The migration test results are within the limits set by current regulations, 10 dm<sup>2</sup> of food contact surface.

No Dual-use additives are used.

This declaration of compliance has been drawn up on the basis of:

- Analysis of overall migration


